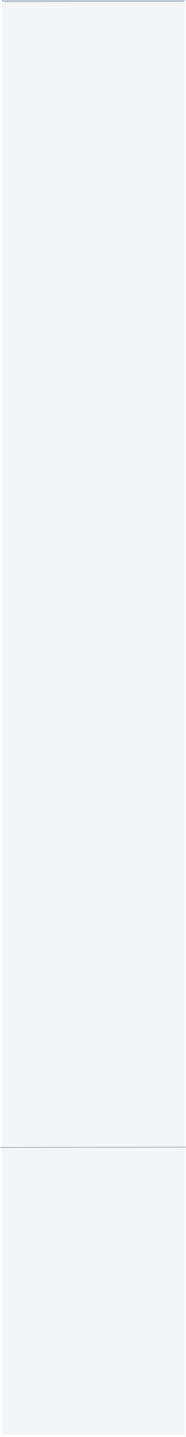

Rationale for Program Creation	
(A) Why is the program being proposed?*	<p>Given the comprehensiveness of the AACSB review process, which includes all undergraduate and graduate programs in the business college, including the M.S. program, this process serves to support the Eberly College academic program review requirements. Of the eighteen credits from the business core; Accounting majors must select at least three courses with the finance prefix and no more than a total fifteen credits at the 500 level. Of the eighteen credits from the business core; Finance majors must select at least three courses with the accounting prefix and no more than a total fifteen credits at the 500 level. Students Entering the Finance Track must have completed Intermediate Accounting I and II.</p>
